(b) Work out how many euros Tiegan will get from Travelex


(c) State which girl gets the best deal for their money, and give a reason for why you think they get the best deal?

Use this information to complete Devon's payslip and work out her net pay for the week.





(c) State which girl gets the best deal for their money, and give a reason for why you think they get the best deal?


2 The Jones family are flying to London for Easter and their flight leaves at 11.40 am. They have to be at check in at least 60 minutes before the flight leaves.




